**Position Summary:** The Director of Gaming is responsible for overseeing all gaming operations within the casino, ensuring compliance with regulatory requirements, maximizing profitability, and delivering an exceptional guest experience. This leadership role will work closely with department heads, the executive team, and regulatory agencies to maintain high operational standards and develop strategic initiatives that align with the casino's goals and tribal values.

## Major Duties and Responsibilities:

- Manage all aspects of gaming operations, including slot machines, table games, poker rooms, bingo, and sportsbook, ensuring efficient and profitable performance.
- Ensure compliance with all tribal, state, and federal gaming regulations, maintaining the highest standards of integrity and security.
- Develop and implement strategies to increase revenue, enhance customer experience, and optimize gaming floor layouts based on market trends and customer feedback.
- Prepare and manage the gaming department's budget, including forecasting revenues, controlling expenses, and ensuring cost-effective operations.
- Lead, mentor, and develop gaming staff, including department managers and supervisors, fostering a culture of teamwork, professionalism, and continuous improvement.
- Monitor and enhance the guest experience on the gaming floor, implementing customer service standards and resolving escalated guest issues effectively.
